Under the title *What Manner of Men*, the book should be available in May in time for the Triennial Meetings.

Professor James O'Hara Denny, chairman of the Pennsylvania Society's committee on the Triennial Meetings, has announced the triennial schedule.

In addition to those regular events connected with the meetings, Clifford Lewis 3d has helped organize open houses at Revolutionary sites for May first. Currently plans are underway for a six month exhibit at Brandywine centering on Cincinnati participation in the battle. The formal opening of that exhibit will be May first. Members arriving that day will also be able to see other Revolutionary houses and encampments. The Pennsylvania Society will send out a list of places to visit supplemented with restaurant suggestions.

Clifford Lewis 3d, History Editor of *Cincinnati Fourteen* and Chairman of the Brandywine Battlefield Historic Park State Commission reports that the elaborate Lafayette birthday planned for September 7 had to be cancelled due to the amount of work involved. It has been rescheduled for next year.

He further reports, however, that the annual Associators Muster at Brandywine of Revolutionary Units was held on September 7 and 8. The muster was reviewed by Mr. Lewis and by Pennsylvania member John Cole Tuten, Jr., whose forebear Lt. Andrew Lytle was in the battle.

At the Anderson House Meetings m October, the History Committee and Standing Committee made further plans for the Cincinnati History Prize announced in the last issue . The \$5,000 prize for the best book on the Revolutionary period will be given first in 1988 . Dr. Bartholomew Cox of the Pennsylvania Society is developing details of the administration of the prize , while Clifford Lewis 3d is taking on the task of finding a permanent endowment to support the award .
